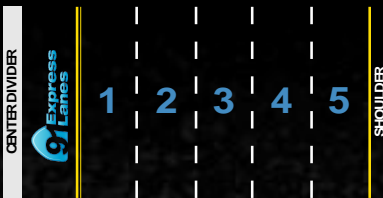
Daytime and Nighttime Lane and Ramp Closures Lakeview Ave. to Weir Canyon Rd. February 27 - March 2, 2012

WHAT:

Daytime and nighttime lane and ramp closures will occur on SR-91. The closures will allow crews to safely continue ramp work at Weir Canyon Rd./Yorba Linda Blvd. and Lakeview Ave., open the eastbound weigh station and conduct work on local streets.

- One new six-mile lane in the westbound and eastbound directions between SR-241 and SR-55
- Standardized 12-foot lanes and 10-foot right shoulders
- Widened undercrossing at Weir Canyon Road/Yorba Linda Blvd. and Imperial Highway in the westbound and eastbound directions
- New restriping throughout project limits
- Soundwall on eastbound side of the freeway along key residential area
